### REGULAR BOARD MEETING MINUTES

CALL TO ORDER/ROLL CALL: Board Chair Tom Allen called the Regular Board Meeting to order at 0900 hours. Members of the Board that attended the virtual meeting included: Board Chair Tom Allen, Board Clerk Mrs. Nancy Schuster, Mr. Jeff Jamieson, Mr. Bill Katzel and Mrs. Sandi Richey. See attached electronic sign-in sheets for Green Valley Fire District staff, Green Valley Fire Corps, and members of the public present.

**PLEDGE OF ALLEGIANCE:** Mrs. Schuster led the members of the Board and staff in the Pledge of Allegiance.

**CALL TO THE PUBLIC:** There were no members of the public logged in to the meeting who wished to address the Board.

CLERK'S REPORT: Mrs. Schuster – Mrs. Schuster presented the minutes from the Regular Meeting of March 25, 2020 and the Special Board Meeting of April 9, 2020 for approval. Mr. Katzel made a motion to approve both sets of minutes. Mr. Allen seconded the motion. All were in favor, and the minutes were approved, (5-0).

**LOCAL PENSION BOARD UPDATE: Mrs. Richey-** Mrs. Richey advised that a meeting was held on April 27, 2020, approving Captain Abel Soto into the drop. His drop date is set for May 22, 2020.

#### REPORTS AND CORRESPONDENCE

### A. CHIEF'S REPORT: Chief Wunder -

- 1. Employee/Community Recognition Chief Wunder expressed his gratitude and stated that he was proud of all GVFD staff for their handling and cooperation throughout the ongoing COVID-19 crisis. A special thank you was relayed to Chief Rowe and Captain Taormina for their extensive efforts to find and maintain supplies and equipment, amidst the challenges with depleted supplies nationwide.
- Legislative Issues Chief Wunder advised that there are no new major legislative issues. He stated reimbursement funding is likely to continue to be a primary focus and growing concern due to the COVID-19 pandemic.

- 3. GVFFA Meet & Confer Update Chief Wunder advised that the meeting was cancelled; however, progress remains on track. The Union has been providing helpful resources for families affected by COVID-19.
- **4. Administrative/Management Update** Chief Wunder advised that the budget remains on track. Budget and benefits have been the primary focus. Administrative Manager Talia Carey successfully accomplished finalization of open enrollment, which is effective May 1, 2020.
- **5. Valley Emergency Communication Center (VECC) Update** Chief Wunder provided an update on the VECC, advising that progress remains on track with an anticipated go live date for Rapid Deploy in May. There were no questions.
